

ORDER

In terms of Board's order of even number dated 25.11.2010, one post of OS-Gr-I, PB-II+G.P.4600/- was transferred from RRB/Allahabad to Board's Office for its operation as Inspector, PB-II+G.P.4600/- in E(RRB) Branch under Establishment Directorate for a period of one year from the date of its operation. The post had come in operation w.e.f. 27.12.2010.

3. Accordingly, sanction of the Ministry of Railways is now hereby communicated, post-facto, to:


