NOTIFICATION

Sub: Re-engagement of Retired Railway Gazetted Officers as Consultant in Accounts Department of ICF — Reg.

Ref: Railway Board's letter No.2024/ E (GR) I /38 / I dated.29.08.2024& 08.11.2024

- In terms of Railway Board's letters cited and with the approval of the competent Authority, it is proposed to re-engage Retired Railway Gazetted Officers as Consultants to fill up the vacant posts in JAG (Level 12) and JTS(Level 10) in Accounts Department of Integral Coach Factory(ICF), Chennai-600038.
- **II.** Applications are invited from the eligible officers who retired from Railway services for reengagement in **Accounts Department**, Integral Coach Factory for the following vacancies:
 - (i) From retired Officers in Level 13 for re-engagement as Consultant in exigencies of the services against vacant JAG post in Level 12 and
 - (ii) From retired Officers in JTS (Level-10), STS (Level-11) & JAG (Level -12) for reengagement as Consultant in exigencies of the services against vacant posts of AFA in JTS (Level -10)
 - (iii) This scheme for re-engagement of Retired Railway Gazetted Officers shall be valid only up to 31.12.2026.

Note: The place of posting will be in the Accounts Department of Integral Coach Factory.

V. Eligibility:

- (i) Retired Railway Officers of Accounts Department from Level 13 are eligible to apply for the vacancy in Level 12 (ii)Retired Officers from JTS (Level-10), STS (Level-11) & JAG (Level-12) are eligible to apply against 2 vacancies in Level 10 (JTS).
- 2. Age limit: Maximum age limit for re-engagement shall be 65 years.
- 3. Medical fitness: Should be medically fit in the appropriate category as done in the Selection from Group 'C' to Group 'B'.

VI How to apply:-

- 1. The eligible retired Railway Gazetted Officers who are willing to apply are advised to read the entire Notification along with the Annexures uploaded in the Accounts website/ICF.
- 2. The applications received will be treated as "Invalid/Ineligible" on the following grounds:
 - (i) Unsigned application.
 - (ii) Application without affixing latest photograph.
 - (iii) Incomplete Application
 - (iv) Application without copies as indicated in Annexure D.

Annexure-A

TERMS & CONDITIONS:

- 1. Re-engagement of retired Accounts Officers (Gazetted) is for filling up of 1 JAG post in Level 12 and 2 JTS posts of AFA in Level 10.
- 2. The applicants cannot be considered against vacancies in a level higher than what they had retired from.
- 3. Remuneration: A Fixed Monthly Remuneration shall be admissible arrived at by detecting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. Annual increment/ percentage increase and Dearness Allowance shall NOT be allowed during the contract period. (Example for determining remuneration shall be as given in DoE's OM No.F.No.3-25/2020-E.IIIA, dated 09.12.2020).
- 4. Maximum age limit of the re-engagement shall be 65 years.
- 5. Suitability / competency of the retired officer shall be adjudged on the basis of last five APARs as per established norms for a DPC, before such re-engagement by a three member committee of PHODs/CHODs, as appointed by General Manager. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
- 6. The period of re-engagement shall be initially for a period of ONE year and further extendable as per requirement. No retired officer shall be engaged beyond the validity of the scheme i.e. 31.12.2026.
- 7. The re-engagement of Consultant shall not be considered as a case of re-employment.
- 8. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed nor carried forward in case the engagement is extended. Also, no payment in lieu of unutilized leave will be paid at the time of discharge / expiry of the contract.
- 9. The Re-engaged officer shall not be entitled for HRA and residential accommodation. However, Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment; they may be allowed TA/DA for official tour, if any, as per their entitlement at the time of retirement.
- 10. The designation shall be Consultant followed by (trade name) e.g., an Officer appointed against the above posts shall be designated as Consultant (Accounts).

For PFA/ICF

- 11. The re-engaged Officer shall be given responsibilities like inspections, supervision, etc.
- 12. The re-engaged Officer shall not be made in-charge of units like any Branch Officer in divisions nor be given independent charge in any Construction unit. They shall not be given Financial and D&AR powers. However, they may recommend suggestions on financial and other matters to regular Officers.
- 13. The re-engaged Officer shall not divulge any information gathered by him/her during the period of assignment related to the organization to anyone who is not authorized to know / have the same. For this purpose, the Consultant shall sign an Agreement of Confidentiality with the Govt. of India containing a clause on Ethics and Integrity.
- 14. The re-engaged officer shall be discharged immediately on joining of Selected Candidate(s) from UPSC or through departmental Selection or for any other reason as per administrative convenience based on the recommendation of PHOD/CHOD concerned.
