1.0	In terms of Railway Board's letter above reference applications are invited in prescribed Proforma from willing retired Non-Gazetted IT Centre staff in Pay Level-7 (also MACP Pay Level-8 & 9) for re-engagement on monthly remuneration basis for the following post in Integral Coach Factory, Chennai 600 038.

2.0	<u>ELIGIBILITY CRITERIA:</u> a) Retired Non-Gazetted Staff who has retired from IT Centre /Zonal Railways / PUS' of Indian Railways in Pay Level-7 (also MACP Pay Level-8 & 9) from relevant grades on or before the date of publication of Notification b) Retired Railway Non-Gazetted staff should not have been compulsorily retired or removed or dismissed from service. Retired Railway employees should be free from D&AR and Vigilance cases at the time of Retirement. (Moreover, he/she should not have any criminal case/Police case pending before any court of law till application date)

4.0	Other Conditions :				
4.1	The Re-engagement will be for a period of 1 year or till further orders, whichever is earlier. However, based on satisfactory performance of a re-engaged retired staff, his/her period of engagement can further be extended for a further period of one year or till the continuation of the scheme or till attainment of 65 years of age, whichever is earlier.

4.2	The Administration reserves the right to terminate the services of the re-engaged retired railway employees at any time, in case their work or conduct is found unsatisfactory or in administrative exigencies. The decision of the ICF administration is final.
4.3	The employees should be free from DAR/Vigilance cases.
4.4	Re-engagement shall be subject to prescribed medial fitness for the category in which they are engaged.
4.5	Retired employees being re-engaged, should not have been covered under the Safety Related Retirement Scheme/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS).
4.6	Suitability/competency of the staff will be adjudged by a Committee. The integrity aspect will also be checked while permitting such re-engagement.
4.7	Monthly remuneration of the retired re-engaged employee will be determined in terms of RBE No.96/2024 dated 15.10.2024. A fixed monthly remuneration shall be admissible arrived at by deducting the Basic Pension from the Pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the terms of the contract. Annual Increment/percentage increase and Dearness Allowance shall NOT be allowed during the term of the contract.
4.8	Re-engaged employee shall NOT be entitled for HRA and Residential Accommodation . However, Transport Allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the retired employee at the time of retirement. The amount so fixed shall remain unchanged during the term of re-engagement. They may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
4.9	Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year will not be allowed nor carried forward in case the engagement is extended. Also, no payment in lieu of unutilized leave will be paid at the time of discharge / expiry of the contract.
4.10	The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
4.11	The duty hours of the re-engaged employees would be as prescribed by Competent Authority as per the working conditions of the category with weekly off for one day.
4.12	Re-engaged staff shall be discharged Immediately on joining of selected candidates from RRBs, CGA, GDCE(RRC) or through Departmental Selection or for any other reasons as per Administrative convenience based on the recommendation of PHOD/CHOD concerned.
4.13	Re-engaged staff shall not be given the financial and D&AR powers and shall not be authorized to issue any safety certificate. However, they can recommend their suggestions on financial and other matters to regular or in-service staff / Officer.
5.0	How to apply
5.1	Application should be submitted in the prescribed format enclosed as Annexure I & II. All columns therein being mandatory.
5.2	Application format available in the ACCOUNTS WEBSITE/ICF can be downloaded, filled in and printout of the same must be sent through post along with enclosures.
5.3	The recent passport size photograph should be affixed in the space provided in the application.
5.4	The applicant should sign legibly in the space provided.
5.5	Self-attested photocopies of the following documents should be enclosed.
